If approved, our state would have to set up a special election and select 75 delegates to represent each of the House of Representative districts. These delegates set up their own agenda with little accountability, public input, or checks and balances on changes they might propose.

It is estimated that this process would cost us taxpayers around \$4 million. It is also an invitation for special interests with much more money that our union brethren have to influence the delegates.

The last time RI held a convention our Constitution was amended to include antiabortion language and restrictions on voting requirements. In 2014 there was a huge anti-labor movement that was working to limit collective bargaining rights to salary ONLY. This would mean that we would have no input or control over the length of the school day or year, prep time, lunch breaks, job placements, and more.

Project 2025 & Trump's Agenda 47 Call for the Elimination of the Department of Education -What would this mean?

Funding: Federal money makes up around 11% of all public school funding nationwide. While Trump's campaign agenda doesn't specify how it will deal with Title I funding, Project 2025 proposes that the program be phased out over a ten year period.

Privatization: Both Trump's 47 Agenda and Project 2025 call for vouchers that could be used for religous schools and, more importantly, non-unionized schools.

Abolishing Teacher Tenure: Trump's plan will implement funding preferences for schools that abolish tenure and adopt merit pay programs.

Censuring Curriculum: Trump plans to reinstate his 1776 Commission and create a credentialing body to certify teachers who embrace patriotic values. Get ready for many book bans.
