On Tuesday, April 8, 2025, the Coventry Teachers' Alliance (CTA) awarded \$125,000 in scholarships to graduating seniors at Coventry High School. The awards were made through the CTA Scholarship Fund to assist students enrolling in post-secondary schools. Support the Rule of 90 for Public **Employees**

Leaislation to improve retirement eliaibility known as the "Rule of 90"—is currently under consideration in the Rhode Island General Assembly.

The RIFTHP has prioritized strengthening pension would allow eligible employees to retire a few years earlier than is currently permitted under Rhode Island law. Legislation to enact this proposal has been introduced by Representative Deborah Fellela (H 5198) and ^{t,}Senator Frank Ciccone (S 450).

This proposal impacts public employees in the state, teachers, and the Municipal Employees Retirement System (MERS). It allows employees to retire without penalty at age 60 with 30 or more years of service, a meaninaful change We know this change won't benefit every member immediately, but it represents

meaningful progress. Most employees would gain new retirement flexibility—even if they

Fight for a Fair Pension

These bills impact teachers, state workers, and municipal employees in the Municipal Employees Retirement System (MERS). Currently, the normal retirement age is tied to Social Securitytypically age 67.

Since 2015, early retirement is allowed under the "Rule of 95", where age + years of service = 95 S 450 and H 5198 would create a "Rule of 90", allowing retirement at age 60 with 30+ years of service, without penalty.

Reverse Gutting of Core Worker Safety Agency

Due to Elon Musk and his unaccountable DOGE, we are facing one of the largest mass firings of federal workers in history, including highly technical federal workers who keep us safe on the job.

More than a thousand workers in six states and Washington, D.C., have lost their jobs at the National Institute for Occupational Safety and Health (NIOSH), the federal job safety research agency. By gutting this key organization, America's workers will lose critical safety protections and more workers will get hurt. Every single NIOSH research center is being closed and the few staff remaining no longer have the resources to do their jobs.

Please call your member of Congress and demand they stand up for this critical health and safety agency and its workers against DOGE and the Trump administration.

Our message is simple: Stop the cuts to NIOSH and reinstate their workers. But here are some other details that may help during your call:

Congress created NIOSH (pronounced nighosh) on a broad bipartisan basis.

NIOSH is the only federal government agency that conducts research on worker safety and health, and gathers and analyzes the information to keep workers safe. (More on website)
